## **Company One Theatre Reschedules Summer Production Due To Comm Ave Closures and To Increase Accessibility**

**BOSTON** — Company One Theatre (C1) regrettably announces that their final production of season 18, *Leftovers* by Josh Wilder, will be moved to season 19 due to [significant construction to the Commonwealth Avenue bridge](#) this summer that will impede access to Boston Playwrights' Theatre (the planned venue). However, in moving the production, C1 plans to increase access to this remarkable, original, and timely new work by Josh Wilder. At this time, exact dates and new venue details are pending, but will be shared in a forthcoming Season 19 announcement.

Developed at the O'Neill National Playwrights Conference in 2015 and presently through PlayLab (C1's new play incubator), *Leftovers* combines wit, whimsy, big weeds, and brotherly love into an affecting journey through inner-city experiences in a forgotten corner of Philadelphia.

“It’s not often that a play comes along and manages to create something so current and fresh and energetic,” says C1 Artistic Director Shawn LaCount. “There’s magic here — Wilder’s most recent draft leaps off of the page and demands an audience. However, being at the Boston Public Library with our current production of *peerless* — an entirely Pay-What-You-Want program — has affirmed for me that it is our duty at C1 to break down barriers to attendance to the best of our ability with each project we do. We are making moves towards radically inclusive programming and unbridled access and unfortunately the closures, detours, and limitations put in place by the construction make that impossible.”

The decision to postpone is driven by more than just a philosophical belief in accessible, inclusive theatre. The precarious nature of arts funding at this particular moment makes producing a summer show with such catastrophic obstacles to attendance a financially irresponsible endeavor for the organization at this time.

[A recent article in the Boston Globe](#) details the closures saying, “It will affect nearly every mode of transportation, altering bus and train routes and eliminating most traffic on a 1.5 mile stretch of Commonwealth Avenue and the Boston University Bridge, and choking the turnpike below.” The article confirms that Comm Ave will indeed be open to bike and foot traffic, but restrictions and congestion in the surrounding area will make reaching the venue too difficult for audiences, designers, actors, and staff. As the Globe reports, it is likely that the second phase of construction

on Comm Ave will take place next year, so C1 is ruling out BPT as a future venue for this production as well. At this time, venue and date negotiations are still taking place and more information will be available in the coming months.

“It’s particularly unfortunate timing because after completing two very exciting workshop weeks with Josh, we were eager to see the play in the context of the impending Bill Cosby trial this summer, given its connection to the storyline,” says Summer L. Williams, Associate Artistic Director of C1 and the director of *Leftovers*. “But we are energized to use this time to develop new artists (true Company One fashion) to give Josh a proper introduction to the City, and to roll out the red carpet when we bring it to the stage in 2018!”

“This is a blessing in disguise,” says playwright Josh Wilder. “The premiere of *Leftovers* in 2018 is going to be a triumphant one. Radical access is what this play needs and I think every playwright deserves that opportunity to develop a deeper relationship with an audience. Plus I’ll be finished with my MFA at Yale School of Drama and can really take charge of this opportunity to bring the play to Boston. ”

Over the course of this current season, Josh, Summer, and Director of New Work Ilana M. Brownstein have developed a vision for this play that is inclusive of people who don't often hear their own stories on stage, and don't often feel welcome in the theatre. In the Company One spirit of turning challenges into opportunities, the artistic team looks forward to leveraging C1's robust community engagement initiatives to create new paths of access for audiences from across Boston's rich collection of neighborhoods.

### >>**ABOUT LEFTOVERS BY JOSH WILDER**

Weeds are a given in the heart of Philly, but when a giant dandelion sprouts overnight and wishes start falling from the sky, one family begins to see a way out of the cycle of poverty that has governed their lives. For brothers Jalil and Kwamaine, hope is running thin as they wait for the arrival of their absent father—and in time, discover the power of their own dreams and the transformative influence of forgiveness. Seizing the possibility of no longer feeling like the city's leftovers, the two brothers find themselves on an adventure they never could have dreamed of.

Josh Wilder is a playwright and actor from Philadelphia. His play *Leftovers* was a recipient of the 2014 Holland New Voices Playwright Award at The Great Plains Theatre Conference. He is a former Jerome Fellow and Many Voices Fellow at The Playwrights’ Center and has been in residence at The Royal Court Theatre. Josh is a MFA candidate in Playwriting at Yale School of Drama.
